BAHAMAS

This is a rollover for the Bahamas Harmonized Tariff Schedule 2008. This rollover changes HS descriptions, duties and excise taxes across the entire tariff.

This is an update to the 2009 Preferential Tariff Schedule. This update modifies the preferential duty rates for several Free Trade Agreements on products classified in various chapters.

Starting in June, Norfolk, Savannah, and Rio Haina will be added to the port rotation, which also includes the following locations: Miami, Kingston, San Juan, St. Martin, Fort de France, St. Lucia, Trinidad, Margarita Island/El Guamache, and Aruba/Oranjestad.

US-ASIA

Hanjin Shipping is pleased to announce the launch of a direct service between Vietnam and the US. The South East & Japan Express (SJX) Service will have the following port rotation: Port Kelang, Singapore, Hong Kong, Yantian, Osaka, Tokyo, Long Beach, and Oakland. Starting July 7th, Hong Kong will be replaced by Ho Chi Minh. As the new service will include Japanese ports, the existing China America Express (CAX) Service will no longer call Osaka and Tokyo.
